Our current bylaws are not aligned with the best practices of most other student organizations across the province and country. The organizational structure of the RRUSA, voting rights of members, and elections procedures are just a few of the crucial areas that need to be addressed.

The proposed changes create a strong constitution and set of bylaws that empowers our membership and strengthens the organization by striving for good governance.

Additionally, the Society to date has no ratified policies or procedures to support the board in governing RRUSA. Policies and procedures provide a roadmap for day-to-day operations, ensure compliance with laws and regulations, give guidance for decision-making, and streamline internal processes.

- Bachelor of Business Administration Representative (On Campus) shall become an At-Large board member.
